# Problem

Review of transparency information showed:

- inconsistent presentation
- confusion about what needs to be published
- users unable to find or compare data

# Solution

- 1) Create **transparency collections**  
(corporate commitments only)
- 2) Create **template text** for collections,  
publications and documents  
(eg title, summary, body)
- 3) Create **dataset templates** for practitioners

# 1) New transparency collection pages

- Ministerial gifts, hospitality, travel and meetings YYYY
- Special advisers' gifts, hospitality and meetings YYYY
- Senior officials' business expenses, hospitality and meetings YYYY
- Government procurement card spending for YYYY
- Departmental spending over £25,000 for YYYY
- Departmental exceptions to spending controls, YYYY
- Departmental roles and salaries, YYYY
- Departmental workforce management information, YYYY

## 2) Template text: transparency collections

The new templates include text for titles, summaries, details and documents (attachments)
